1. Overview of Operating Results, etc.

(1) Explanation of operating results

(a) Financial performance during the first half of fiscal 2025

During the period under review (January 1 to June 30, 2025), the global economy faced heightened concerns over an economic slowdown due to the tariff policies implemented by the Trump administration in the United States. In addition, geopolitical risks stemming from the prolonged Ukraine conflict and escalating tensions in the Middle East further heightened uncertainty about the future. Amid this environment, the U.S. economy remained resilient, China continued to face deflationary pressures, and Europe experienced low growth. Meanwhile, the Japanese economy saw a gradual recovery in economic conditions due to improvements in the employment environment and the recovery of inbound demand, but the momentum weakened due to rising prices.

Under these circumstances, the Group focused on sales expansion activities and cost reductions, as well as on investments for future growth, such as the expansion of manufacturing facilities, the strengthening of R&D capabilities, and the establishment of overseas bases. As a result, the Group recorded the following financial results for the period under review.

(b) Performance by segment

I. Commodity Chemicals

Electrolysis products recorded lower sales revenue due to a decrease in the sales volume increased in the previous fiscal year. Acrylic monomer products saw a decrease in sales revenue due to lower sales volumes of some products. Industrial gases posted lower sales revenue due to a decrease in sales volume caused by a manufacturing company's operational stoppage resulting from problems at the manufacturing company. As a result of the above, this segment posted net sales of \(\frac{1}{3}\)6,180 million (-5.7% YOY).

Operating income totaled ¥4,681 million (+11.7% YOY) due to a reduction in fixed costs, which partially offset decreased overall sales volume.

II. Polymer & Oligomer

Acrylic polymers saw lower sales revenue due to a decrease in sales volume. Acrylic oligomers recorded higher sales revenue due to revised selling prices. Polymer flocculants posted an increase in sales revenue due to higher sales volume overseas. As a result of these factors, this segment posted net sales of ¥17,538 million (+1.7% YOY).

Operating income decreased 40.4% year on year to \(\frac{1}{2}\),266 million due mainly to higher raw material prices.

III. Adhesive Material

For consumers, sales revenue increased owing to higher sales volume in Japan and the United States and selling price revisions in Japan. Functional adhesives saw an increase in sales volume for automotive parts and smartphone components, resulting in an increase in sales revenue. As a result, this segment posted net sales of ¥6,761 million (+2.6% YOY).

Operating income totaled \(\frac{4}{263}\) million (+13.4% YOY) due to higher sales volume.

IV. Performance Chemicals

High-purity inorganic chemicals recorded lower sales revenue due to a decrease in sales volume resulting from a delay in the recovery of the overall semiconductor market, despite a strong growth in demand for AI applications. Inorganic functional materials posted higher sales revenue due to an increase in sales volume of inorganic deodorants. As a result, this segment posted net sales of \$5,013 million (-1.3% YOY).

Operating income fell 21.7% year on year to ¥459 million resulting from a decrease in sales volume of high-purity inorganic chemicals.

V. Plastics

Environment & infrastructure system (formerly, piping equipment) saw higher sales revenue due to selling price revisions corresponding to an increase in raw material prices. Nursing care products posted a decline in sales revenue due to diminished sales volume resulting from sluggish demand for nursing care products. Ecological materials (formerly, elastomer compounds) saw higher sales revenue due to an increase in sales volume in our base in Thailand. As a result, this segment posted net sales of ¥13,733 million (+3.2% YOY).

Operating income increased 81.0% year on year to \$1,172 million thanks to increased sales of products for infrastructure aging countermeasures in the environment & infrastructure system and price revisions in the nursing care products.

VI. Other Businesses

This segment, which consists of the research and development business for new products, goods transportation, and trading-house operations, among others, recorded increased sales revenue in its trading department. As a result, this segment posted net sales of \(\frac{\pma}{1}\),117 million (+14.6% YOY)

Operating loss totaled \(\frac{4}{821}\) million, compared to an operating loss of \(\frac{4}{462}\) million in the same period of the previous fiscal year, partly because of the increase in costs associated with the Kawasaki Frontience R&D Center.

(2) Explanation of financial position

I. Status of assets, liabilities, and net assets

Total assets: Total assets amounted to \(\frac{\pmathbb{2}}{269},837\) million, down \(\frac{\pmathbb{8}}{8},182\) million (2.9%) from the end of the previous fiscal year. The main contributor to this decrease was a decrease in current assets such as "securities" despite an increase in "other, net" under non-current assets owing to the increase in construction in progress.

Total liabilities: Total liabilities amounted to ¥59,194 million, down ¥5,158 million (8.0%) from the end of the previous fiscal year. The main contributor to this decrease was a decrease in "other current liabilities" in current liabilities due to lower accounts payable other.

Net worth ratio: Net worth ratio amounted to 77.7%.

II. Status of cash flows

Cash flows from operating activities: Net cash provided by operating activities totaled \$16,678 million, an increase of \$2,423 million compared to the previous first half, resulting from a decrease in receivables.

Cash flows from investing activities: Net cash used in investing activities totaled \(\pm\)17,313 million, an increase of \(\pm\7,251 million compared to the previous first half. This was attributable to an increase in purchase of property, plant and equipment.

Cash flows from financing activities: Net cash used in financing activities totaled \(\frac{4}{8}\),712 million, a decrease of \(\frac{4}{277}\) million compared to the previous first half. This result reflected a decrease in dividends paid.

As a result, the balance of cash and cash equivalents at the end of the period under review was \(\frac{4}{30}\),534 million, a decrease of \(\frac{4}{9}\),898 million from the end of the previous fiscal year.

(3) Explanation of forward-looking statements such as consolidated performance forecasts

All forward-looking statements herein represent assumptions that we considered reasonable as of the day this document was published.

In terms of performance during the first half of fiscal 2025, sales volume declined for many products, including commodity chemicals despite our efforts focused on sales expansion activities, price revisions, and cost reductions. Although the economic situation for the third quarter of fiscal 2025 and thereafter is expected to remain uncertain and difficult to predict due to factors such as the details of U.S. tariff policies and ongoing geopolitical risks, we will endeavor to ensure business expansion and profitability while carefully monitoring and flexibly responding to market conditions and trends in raw material and fuel prices.

Amid this situation, although there are some fields where demand recovery is expected and developed products with strong sales, the Company forecasts that net sales, operating income, ordinary profit, and net income attributable to owners of parent for fiscal 2025 will fall short of the consolidated performance forecast announced on February 13, 2025.

Application of Accounting Standard for Current Income Taxes, etc.

The Company has applied the Accounting Standard for Current Income Taxes (Accounting Standards Board of Japan (ASBJ) Statement No. 27, October 28, 2022; hereinafter referred to as the "Revised Accounting Standard 2022") effective from the beginning of the period under review.

The amendment to categories in which current income taxes should be recorded (taxes on other comprehensive income) follows the transitional treatment prescribed in the proviso of paragraph 20-3 of the Revised Accounting Standard 2022 and the transitional treatment prescribed in the proviso (2) of paragraph 65-2 of the Guidance on Accounting Standard for Tax Effect Accounting (ASBJ Guidance No. 28, October 28, 2022; hereinafter referred to as the "Revised Guidance 2022"). This change in accounting policies has no impact on the semi-annual consolidated financial statements.

For the amendment related to the revised accounting treatment for consolidated financial statements when gains or losses on sale of shares in subsidiaries resulting from transactions between consolidated companies were deferred for tax purposes, the Revised Guidance 2022 has been adopted from the beginning of the period under review. This change in accounting policies is applied retrospectively, and semi-annual consolidated financial statements and consolidated financial statements for the previous fiscal year are after retrospective application. This change in accounting policies has no impact on the semi-annual consolidated financial statements for the same first six-month period of the previous fiscal year or the consolidated financial statements for the previous fiscal year.

Conclusion of an important agreement

The Company's consolidated subsidiary, Toagosei America Inc. (hereinafter, "TUS"), concluded an agreement on July 1, 2025 primarily regarding the dissolution of Elmer's & Toagosei Co. (hereinafter, "E&T"), a joint venture between TUS and the Newell Brands Inc. (hereinafter, "NB") Group after acquiring the NB Group's equity interest in E&T from the NB Group.

1. Reasons for dissolving the partnership

The Group manufactures and sells Aron Alpha, which has become synonymous with instant adhesives. In the U.S., E&T, an equity-method joint venture, sells instant adhesives under the trademark Krazy Glue. While Krazy Glue has enjoyed over 50 years of popularity and strong brand recognition, the market has become increasingly competitive in recent years.

The Adhesive Material segment is a core business for the Group. The business is growing not only because our consumer products have strong brand recognition but also because we offer high-performance, high-value-added adhesives used in automobiles, electronic materials, and other applications. Moving forward, we plan to accelerate our overseas expansion in the manufacturing and sales of Krazy Glue. Until now, we have been marketing and selling Krazy Glue through E&T, a joint venture between TUS and the NB Group. However, we have decided to dissolve this venture by acquiring the equity interest held by the NB Group and pursue an independent strategy to build strong operations that are even more flexible and agile.

Looking ahead, we will further strengthen the Krazy Glue business and increase its market share by leveraging our integrated groupwide production and sales structure.

TUS and the NB Group each hold a 50% equity interest in E&T, but simultaneously with TUS's acquiring the NB Group's equity interest on August 1, 2025, the joint venture agreement will be terminated. In connection with this, TUS will pay US\$22 million to the NB Group and enter into an agreement with the NB Group regarding the transfer of sales-related operations on the same day. Furthermore, as a result of the acquisition of the equity interest and the termination of the joint venture agreement, E&T will be dissolved, and TUS will succeed to the assets remaining in E&T.

5. Significant impact of the conclusion of the agreement on business operations

With the dissolution of E&T, the company will be excluded from the scope of the Company's equity method affiliates in the fiscal year under review. The impact of this matter on the consolidated financial results for the fiscal year under review is immaterial.
